## Food Vendor Application

### SELECTION CRITERIA:

- There will be a limited number of stall spaces available for food vendors at each market.
- Vendors who sell products that have the following attributes are more likely to be awarded a stall to sell at the MFMI:
  - The primary ingredients are grown or produced locally by the vendor.
  - Healthy options are offered.
  - Well suited for lunch for those taking a break from work.
  - Uniqueness
  - A similar food is not already being sold at the market.

### REQUIREMENTS:

Obtain necessary health permits. You must have the required permit in your possession when you arrive or you will not be allowed to setup your concession.

Provide your own booth, tables, chairs, garbage cans, fire extinguishers, materials, etc. The Minocqua Farmers' Market Inc. (MFMI) will not have equipment available for your use. You must also supply attractive, colorful signs with the name of your business/organization, items that you are selling, and their prices.

Provide water buckets/cleaning buckets for your own booth needs as community water service locations are limited.

Vendors must keep their sales area clean of all types of refuse and are responsible for cleaning up their area after each day's sale and taking their refuse with them.
